- 一、本人保證符合下列情況之一:

- 3. 申請時兼具中華民國國籍,但從未在臺設籍,且最近連續居留海外\*\*六年以上\*,並未曾以僑生身分在臺就學,且未於當學年度經海外聯合招生委員會分發。
- 4. 具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時 於香港、澳門或海外\*\*連續居留滿六年以上\*;
- 5. 曾為大陸地區人民具外國國籍且未曾在臺設籍,申請時已連續居留海外六年以上\*。
- \* 計算至學期起始日止:春季班為二月一日,秋季班為八月一日。
- \*\* 除非有明確寫出,海外地區指中國大陸、香港及澳門以外之國家或地區。
- 二、如申請學士學位學程(申請碩士或博士學位學程者請略過此項),本人保證符合下列情況之一。

- 1. 此為本人第一次以外國學生身分申請來臺灣就讀。
- 2. 本人畢業於臺灣之外國僑民學校,或臺灣之高級中等學校附設之雙語部 (班),或私立高級中等以下學校外國課程部班。

三、本人未曾自臺灣的高級中等學校或大專校院退學。

四、本人保證上述事項皆為事實,如有不實,本人願承擔一切相關後果與法律責任。

五、本人所提供之學歷證明,均在畢業學校所在地國家為合法並有效取得之畢 業資格,且所持有之證件相當於中華民國國內各級合法學校授予之相當學位。

六、本人同意國立東華大學可查證本次申請相關之陳述事項及文件,並同意被查證單位提供相關資料以為佐證。如有不實或不符規定等情事經查屬實者,願依中華民國教育部【外國學生來臺就學辦法】第7-1條【外國學生所繳入學證明文件有偽造、假借、塗改等情事,應撤銷錄取資格;已註冊入學者,撤銷其學籍,且不發給任何相關學業證明;如畢業後始發現者,應由學校撤銷其畢業資格並註銷其學位證書。】及承擔其他相關一切法律責任。

- I, the undersigned, declare the following:
- 1. I confirm that my nationality status complies with one of the following:
- a. I never held the Taiwan, R.O.C. nationality, and I am not holding the overseas Chinese student status.
- b. I once held the Taiwan, R.O.C nationality and have renounced it officially for at least eight full years\*; and I have in the immediate past resided overseas\*\* continuously for at least six years\*. In addition, I have never previously undertaken studies in Taiwan as an overseas Chinese student nor have accepted a placement by the University Entrance Committee for Overseas Chinese Students in

the current academic year.

- c. I am holding dual or multiple nationality including Taiwan, R.O.C. nationality, yet I have never had household registration in Taiwan, and I have in the immediate past resided overseas\*\* continuously for at least six years\*. In addition, I have never previously undertaken studies in Taiwan as an overseas Chinese student nor have accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic year.
- d. I am holding foreign nationality and I am eligible for permanent residence in Hong Kong or Macao, yet I have never had household registration in Taiwan, and I have in the immediate past resided in Hong Kong or Macao or overseas\*\* continuously for at least six years\*.
- e. I was formerly from Mainland China (PRC) and currently hold foreign nationality, yet I have never had household registration in Taiwan, and I have resided overseas continuously for at least six years\*.
- \* Until the semester starting date: Feb 1 for spring and Aug 1 for fall semester.
- \*\* Unless explicitly mentioned, the term "overseas" refers to countries or regions other than the Mainland China, Hong Kong, and Macao.
- 2. If applying for a Bachelor's program, I confirm that my status complies with one of the following:
- a. This is the very first time I apply for admission to study in Taiwan as an international student.
- b. I graduated from a private secondary school for international residents in Taiwan, or from a bilingual division (program) affiliated to a domestic senior secondary school, or from a program teaching a foreign curriculum that is offered by a division of a

domestic private senior secondary school.

If your status does not comply with either of the above, please follow the same application procedure as for domestic students. Send a request to admission@gms.ndhu.edu.tw if you need further assistance.

- 3. I have never been dismissed from any educational institute in Taiwan.
- 4. I confirm that all the above information is true, for which I shall bear all the legal responsibility.
- 5. The diploma(s) I provide in my application are valid and legally awarded in the country where I graduated and are equivalent to the degree conferred by accredited schools and universities in Taiwan, R.O.C..
- 6. I hereby state that all of the above declarations are true, and I authorize National Dong Hwa University to verify the above statements and all of my application documents. I also authorize all corporations, companies, and educational institutions to release information they may have about me, and release them from any liability for doing so. If there is any false declaration or documentation, I will accept Article 7-1 mentioned in Regulations Regarding International Students Undertaking Studies in Taiwan, international student who submits any certificate or document as part of their application for admission to an educational institution that is found to be forged, fabricated, or that has been altered in some way shall have their enrollment eligibility revoked. If the student has already registered and begun classes, their registration as a current student shall be cancelled, and they will not be awarded any certification whatsoever regarding their related academic undertakings. If any such circumstances are first discovered after a student has already graduated, the educational institution shall revoke the former student's eligibility to graduate and shall require any degree already awarded to be returned and shall rescind it."
