NDHU Scholarship Regulations for Outstanding New Undergraduate Overseas Chinese Students

Approved by the 5th session of the Administrative Council in the second semester of the Academic Year 2019/2020 on May 13, 2020 Approved by the 1th session of the Administrative Council in the second semester of the Academic Year 2020/2021 on February 24, 2021

- Article 1 This University has formulated these Regulations to promote internationalization and recruitment of international students and reward Overseas Chinese students of good character with outstanding academic performance for enrolling at this University.
- Article 2 Eligibility:

Pursuant to the "Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan" or the "Regulations Regarding Study for Hong Kong and Macao Residents in Taiwan," outstanding Overseas Chinese Students, Hong Kong and Macao Students, or Hong Kong and Macao Students with Foreign Nationality who apply for NDHU are eligible to apply for this scholarship.

- Article 3 Scholarship and quota:
 - (1) Scholarship: A full tuition and miscellaneous fees waiver; living allowance of NTD 36,000 for the first academic year.
 - (2) Quota: 25 students (the actual quota shall be determined by the review board)

Article 4 Application method:

Applications for this scholarship are available every academic year. Overseas Chinese students who apply for this scholarship shall submit the following documents within the designated time announced by the Office of International Affairs.

- (1) Scholarship application form (see attachment) (required)
- (2) A recommendation letter from a teacher (required)
- (3) Senior high school transcripts (with class ranking must be indicated) (required)
- (4) Other documents favorable to the applicant (e.g., award record, creative works, club activity certificate) (optional)

Article 5 Review method:

The Committee of Recruitment of International Students shall select the best candidates based on reviews of the senior high school academic performance, recommendation letters, and other documents favorable to the applicant. The list of scholarship recipients shall be submitted to the President for approval.

Article 6 Criteria and payment:

- (1) Scholarships shall be issued for a period of 12 months with monthly living allowance of NTD 3,000.
- (2) The maximum scholarship duration shall be the freshman year of undergraduate programs.
- (3) Where the academic record of scholarship recipients is ranked in the top 30% of their class, the scholarship shall be continued in the second semester.
- Article 7 Living allowance payments shall be terminated if the recipient's student status changes (e.g., transfer, suspension, expulsion, dropout). Where it is detected upon investigation that the applicant has provided false information, his/her eligibility shall be revoked and living allowance payments shall be terminated. Return of living allowance payments for the respective month shall not be required. Where false information is detected prior to the registration date, applicants shall be required to pay tuition and miscellaneous fees.
- Article 8 These Regulations shall take effect upon ratification by the Administrative Council and approval of the President.
